Clients working with the «Asset Management Package» outside of Asia always receive a local as well as one of the two English news feeds «Dow Jones European Equities Spotlight» or «Dow Jones European Money Spotlight» (as listed below). This encompasses around 1,800 news a day. Clients working with the «Wealth Management Package» will receive a local, internationally focused feed with up to 700 news every day. Clients working with the «Asset Management Package» in Asia always receive «Dow Jones Asian Equities Report».
